SUBJECT: Extension of expiry date of Authorizations for international regular bus lines between Greece and non neighboring countries non-members of EU until 31.01.2017

REF.: Our Prot. Nr. C456/ oik.70151/ 5024/ 23.11.2015 document (forwarding of decision for expiry date extension)

Given that the validity of current Authorisations for international regular bus services between Greece and neighboring countries non-members of the European Union expires on the 31st December 2015, **we hereby inform you that the expiry date of the said Authorisations for the Greek carriers and their foreign partners as well, is extended up to the 31st January 2017, without the necessity of their re-issuing.**

We would like to remind you that, according to the latest Law 4313/2014 "Arrangements on Transport, Telecommunications and Public Works and other provisions" (Greek Government Gazette 261/A/17.12.2014), the obligation for joint operation of the said bus lines, and particularly, the 1:1 ratio concerning the co-operation of transport companies as well as the operation of equal number of routes, no longer exists. However, in the case of changes that concern the terms and conditions under which the related Authorisations were issued in the name of the foreign carriers, according to the Ministerial Decision C456/oik.7383/531/12 (Government Gazette 250/B/13.02.2012), you are kindly requested to inform the concerned carriers for submitting as soon as possible the new relative documents, e.g. table of routes, table of fare scales, registration numbers of buses servicing the lines, etc.

Please, find attached the table of the transport companies entitled to this extension. You are kindly requested to inform the responsible Customs Offices and all competent control bodies in order to assist the even operation of the current bus lines.

The abovementioned are applied without prejudice to the outcome of pending cases to be examined by our Service and possible imposition of administrative sanctions against carriers pursuant to Greek Ministerial Decision C456/oik.8679/662/14 "Legality Check of the traffic of domestic and foreign bus carriers operating international regular bus lines" (O.G. 366, B')

Last but not least, we kindly ask you to provide for the **extension of validity of transit authorizations issued to Greek carriers.**

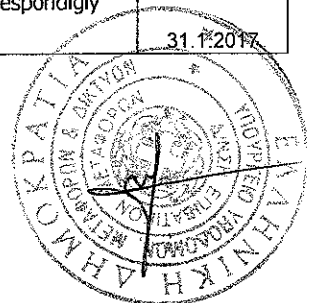
