



TIR-EPD for UN RO-RO

Step-by-step submission process description

1. Submit TIR-EPD as per your itinerary following the usual steps.

NB! “Trieste / Sezione Operativa Territoriale Punto Franco Nuovo” should be indicated as Customs office of Entry to Italy

2. Go to **View all EPDs** section and find the respective TIR-EPD submitted and click on expansion icon  and further on the **Actions** icon 
3. **RORO** link (as shown below) will be activated as soon as “Sent – Wait for reply” status will appear for the respective Customs office (“Trieste / Sezione Operativa Territoriale Punto Franco Nuovo”). **However, it is highly recommended to send RO-RO declaration when the MRN number is already allocated to respective TIR-EPD by Italian Customs.**







10. When the **Current status** is changed to **Sent to Customs**, this means that the electronic information is transmitted to Italian Customs Authorities at the port of destination.

NB! The status of RO-RO Declaration will be changed to **Sent to Customs** only when transport operator has made a reservation on the respective boat for transportation directly with RO-RO Company (UN RO-RO). Selection of respective vessel in TIR-EPD is made only for informative purposes.

11. TSAD form in Italian language that needs to be attached to the TIR Carnet at the port of departure (Pendik), can be printed out by pressing on the  icon as showed above.

The list of available RO-RO statuses:

- **Entered** - the RO-RO declaration was submitted to the system and is available for UN RO-RO staff.
- **Sent to Customs** - the UN RO-RO staff forwarded the data to Italian Customs
- **Cleared** - Italian Customs have accepted the RO-RO declaration
- **Custom Side Errors** – the RO-RO declaration was rejected by the Italian Customs. UN RO-RO staff will contact the Holder to resolve the issue.
