8	Coach driver. - Worker responsible for driving a coach; helps the conductor, including handling transported packages and expedited postage	138V	10,1076 €
9	Coach driver-conductor. - Worker responsible for driving a coach, taking payment from passengers, and handling luggage and goods	140V	10,1813 €
9 bis	Touring coach driver. - Worker having driven a coach for at least two years and meeting all the conditions set out in job description 8 or 9	145V	10,3919 €
10	Long-distance touring coach driver. - Worker normally responsible for driving a luxury touring coach with at least 32 seats; drives long-distance tourist routes, i.e. routes lasting for at least 5 days	150V	10,6445 €

Pursuant to the national collective bargaining agreement, the figures in the table above shall be increased as follows:

- 3 %: workers with a driver or conductor qualification
- €13.75 or €27.49: public holidays
- €13.75 or €27.49: Sundays.
