Submission of preliminary information about the planned transportation through Personal Account



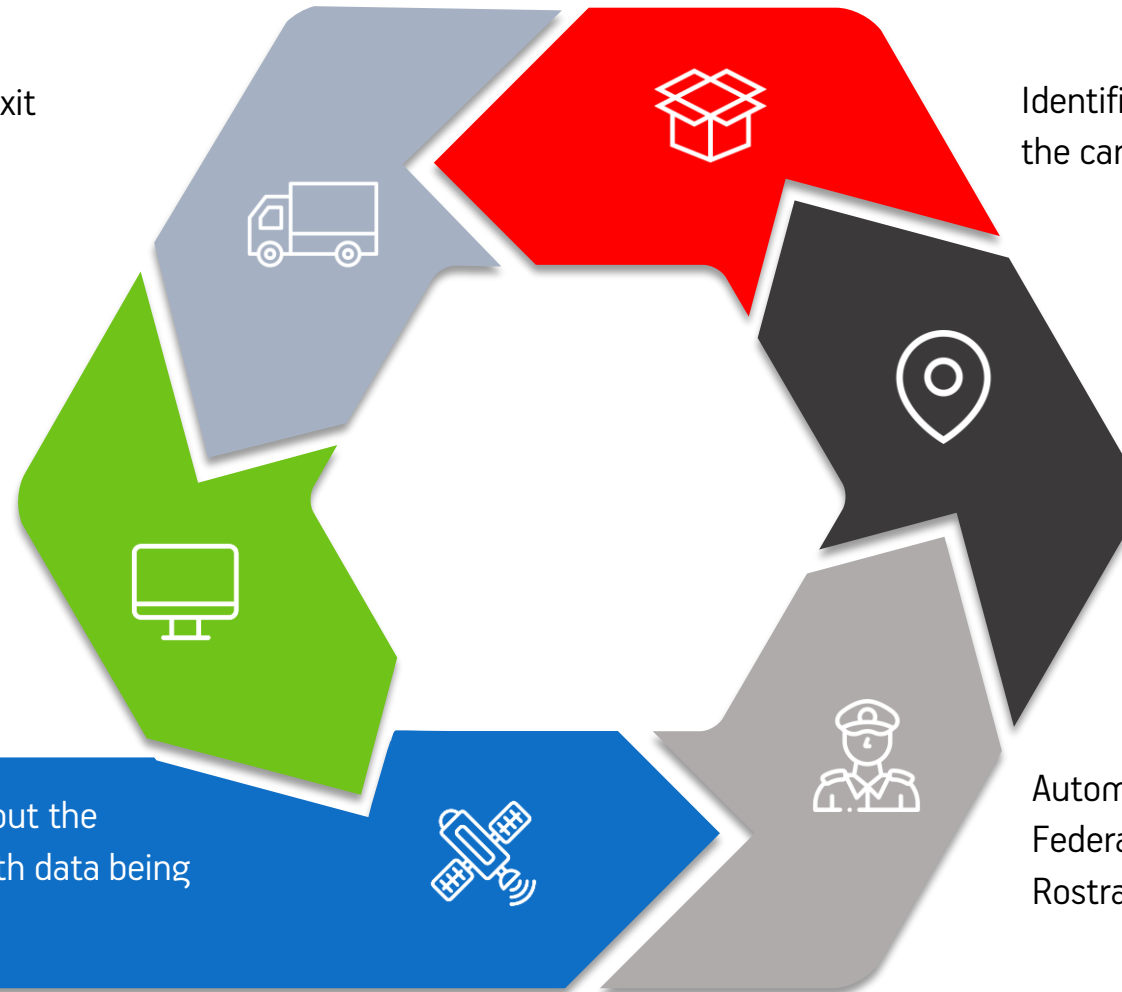
Application and activation of electronic navigation seals at points of entry into the territory of the Russian Federation

# Work Algorithm

Deactivation and removal of ENS at exit points of the Russian Federation

Recording of transportation data in the Carrier Personal Account

Monitoring of transportation throughout the territory of the Russian Federation with data being recorded with the Personal Account



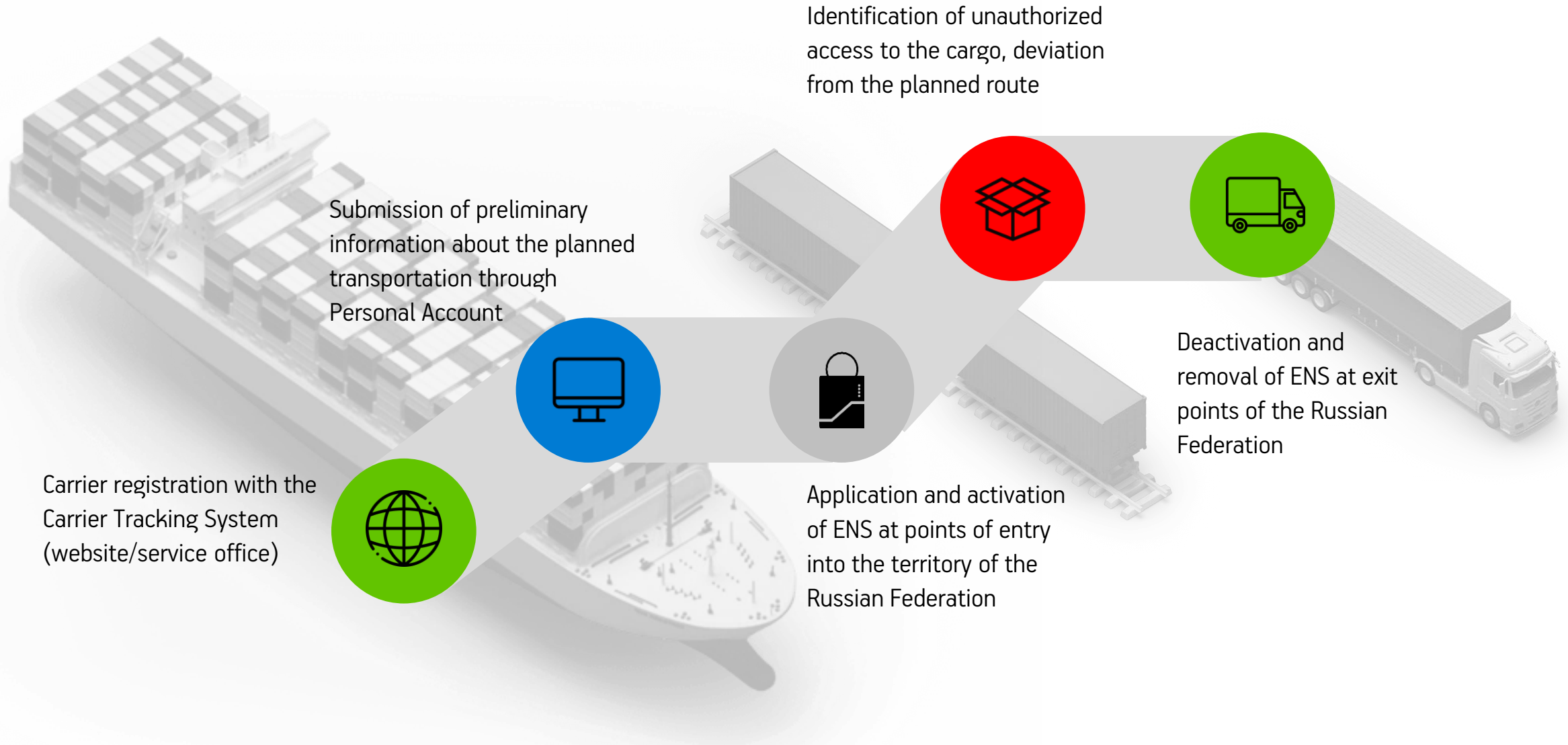
Identification of unauthorized access to the cargo

Automatic transfer of shipping data to Federal Customs Service of Russia and Rostransnadzor officials

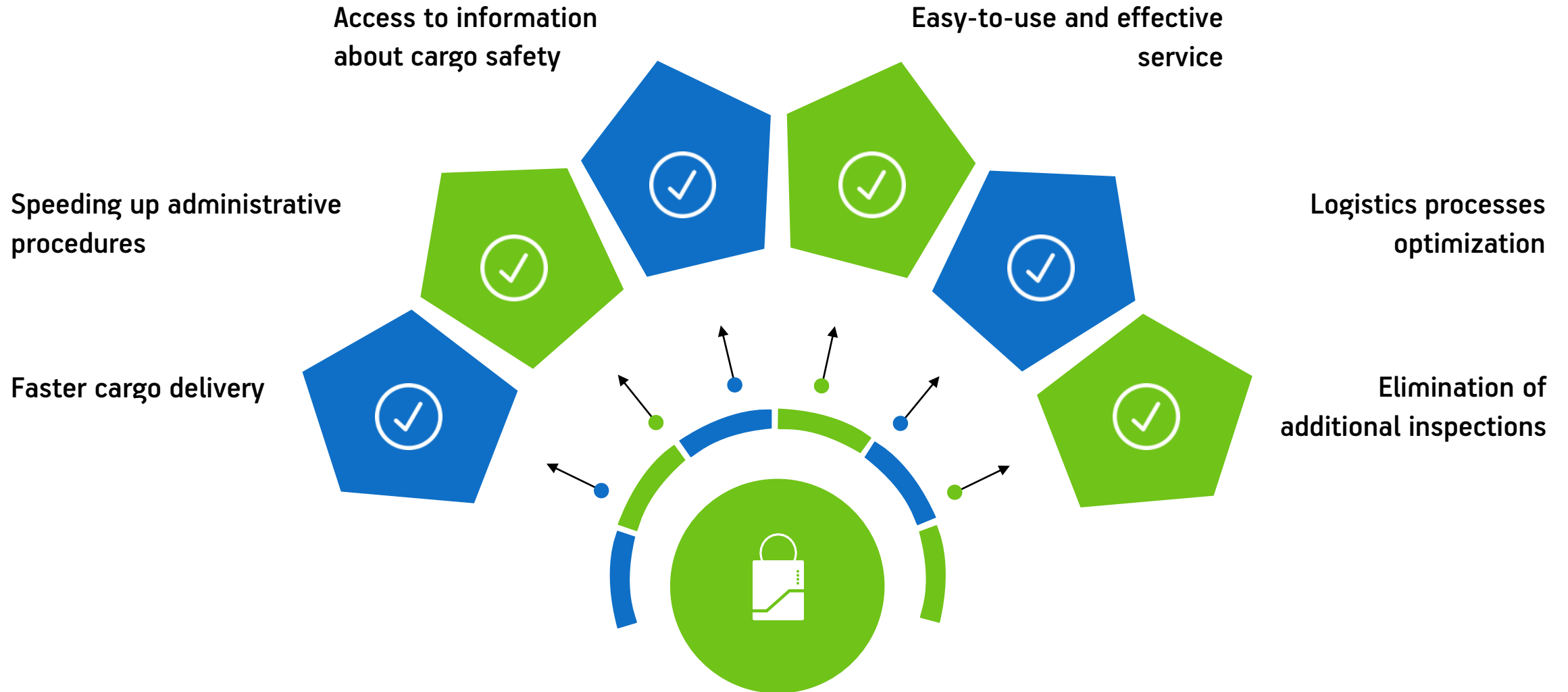

## Use of ENS

As part of the services for provision of control over goods transportation using ENS

**2.500 rubles**

## ENS application on the cargo compartment

When applying the ENS to a single container placed on a fitting platform, the ENS application cost is 2,448 rubles.

**1.224 rubles**

## ENS removal from the cargo compartment

When removing an ENS from a single container placed on a fitting platform, the cost of the ENS removal will be 1,992 rubles.

**996 rubles**
